

Mundra port, Gujarat

1. Violated the Coastal Regulation Zone, and illegally cleared mangrove areas. Fisherman communities continue to protest and have lodged numerous cases in courts. Committee has been formed to look at the matter
2. 2nd Special Economic Zone in Mundra (1,840 hectare) was cancelled when Central government found that Adani “deliberately concealed and falsified material facts”
3. Gujarat courts have found that Adani had illegally constructed an intake channel for its power station at Mundra on private and government land. The company was ordered to give compensation.
4. The Gujarat High Court found that construction was occurring inside an Adani Special Economic Zone (SEZ) at Mundra even though the SEZ had not received environmental approval (an Environmental Clearance from the central government of India).



Chhindwara, Madhya Pradesh

Farmers, labourers and tribals are protesting against illegal commencement of work on the Pench water diversion and coal-fired power plant project from 2004

Orissa

Supreme Court of India ordered 16 firms including Adani to pay 1.75 billion US \$ - 50% of entry taxes dues allegedly payable on goods imported by them for their plants and services in Orissa between 2008 and 2012.

Chandrapur, Maharashtra

Coal Block in Lohara, Chandrapur allotted in 2007. Locals protests and forest officials report got the allocation cancelled as the block would affect 40 tigers in Tadoba-Andhari Tiger Reserve (TATR). Pressure is still being exerted on the government to get clearance or alternative block nearby.

Bellary, Karnataka

Anti-corruption ombudsman (Lokayukta)- large scale illegal exports of iron ore resulting in “huge” economic losses to the Government

Other facts about Adani

- **Duty evasion charges of 25 billion:** Adani and other industries has been accused by Directorate of Revenue Intelligence (DRI) of dodging import duty amounting to about 25 billion US \$ on coal imports. Investigations underway.
- **Denied security clearances:** Adani has failed to win bids for expansion opportunities at the Vizag port, the Chennai port, the Vizhinjam port and the JNPT terminal. It has been denied security clearances for most of these projects due to money laundering charges
- **Land Scam:** There has been an uproar in the Gujarat State Assembly over the allotment of huge tracts of land at throw away prices.
- **Adani demands increase in tariff for imported coal:** Adani Power petitioned India’s regulation setting agency Central Regulatory Electricity Commission (CERC) seeking tariff increase due to import of coal and CERC has ordered compensatory tariff. This means that consumers will pay more for electricity and COAL is not becoming cheaper for Indians
