

I. Long-term Sustainability

SFM is the guiding principle for APRIL and all of its fibre suppliers' operations.

APRIL renews degraded forests to improve productivity of the land and preserves

High Conservation Value areas to conserve biodiversity, environmental

services and community use.

- a) Sources fibre only from non-HCVF areas identified by independent assessments HCV toolkit and peer reviewed by HCV Resource Network
- b) Effective immediately (28.01.14), moratorium throughout supply chain where HCV assessments have not yet been completed
- c) Plantation establishment completed by end 2014 APRIL & supply partners
- d) 100% plantation fibre by end-2019
- e) Robust CoC and sourcing monitoring to ensure only non-HCVF fibre
- f) No new pulp mills or pulp lines until plantation fibre self-sufficiency
- g) All fibre suppliers now mandated to comply with APRIL's SFM policy



II. Forest Protection & Conservation

Commits to protect, manage and enhance forest areas with High Conservation Value and High Carbon Stock

- a) Reaffirms commitment to HCV assessments since 2005
- b) Protects and manages more than 250,000ha of conservation zones
- c) Already restoring 20,000ha of degraded peatland in Riau (RER
- d) Additional 20,000ha to be restored at Pulau Padang
- e) Supports biodiversity and carbon conservation initiatives on a landscape basis. Strives to support conservation areas euqal in size to plantation areas
- f) Pilot study on HCS participating in development of industry-accepted methodology
- g) New concession areas to be best practice in HCS when standards are established



III. Peatland Management

Supports the Government of Indonesia's target to reduce greenhouse gas emissions.

- a) APRIL and suppliers protect and manage forest peatland areas identified as HCVF and HCS
- b) Moratorium on forested peatland areas, incl. canals and other infrastructure activities, until independent HCV assessments have been completed. HCS assessments will be conducted when relevant standards established
- c) Engaged with peat experts to implement best practice management to reduce and avoid GHG emissions within peatland landscapes



IV. Legal Compliance & Certification

Beyond legal compliance toward achieving SFM

- a) Reaffirms commitment to comply with all prevailing laws and regulations
 all fibre suppliers also required to do so
- b) Participating in global SFM certification and encourages fibre suppliers to do so
- c) Has Indonesian Timber Legality Assurance System (INDO-TLAS)/SVLK and OLB/Timber Legality Origin certifications for assurance of timber legality. Annual reviews to maintain certification status



V. Community Engagement & Social Responsibility

Partnerships established with local communities as part of commitment to CSR.

- a) Committed to FPIC principles in Indonesia context
- b) Will resolve any outstanding community conflicts in a fair and transparent manner with input and feedback from stakeholders



VI. Good Corporate Governance/ Transparency

Committed to best practices in good corporate governance & transparency.

- a) Establishing Stakeholder Advisory Committee (SAC) to ensure transparency and implementation of SFM Policy
- b) SAC to appoint independent verification auditor and will oversee monitoring, verification, implementation
- c) WWF, [WBCSD] and others invited to participate in SAC
- d) Regular progress updates for stakeholders



Greenpeace Fiction vs APRIL Facts

Fiction

Largest deforester – cutting down the last remaining rainforest.

SFM policy in response to threat from WBCSD

Continued destruction of forest for another year, six years before it stops using rainforest wood

If serious, would have put an immediate moratorium on all activity

No commitment to implement an immediate moratorium. No commitment to protect all natural forest in supplier concessions

- APRIL plantations are < 0.5% of Indo forest areas
- Conserves > 250,000ha of forests
- Restoring 40,000ha of forest
- Plantation establishment finished in 2014
- Policy has been months in the making involving extensive stakeholder consultation
- HCVF adopted since 2005 250,000ha protected
- Moratorium where assessment not yet completed
- Only uses wood from non-HCVF none by 2019
- Competitor continues to use MHW til 2020
- Slower plantation establishment to allow for progressive protection of HCVF
- · Moratorium on areas not yet assessed
- APRIL 100% plantation in 2019
- HCVF already protected plantations done 2014
- Moratorium in areas not yet assessed
- All wood from non-HCV sources
