Dear Prime Minister,

We are writing to you today to express our serious concerns over the lack of transparency regarding Cairn's Arctic deepwater drilling operations in west Greenland. In particular we are dismayed that Cairn's oil spill response plan has not been made public.

According to the Arctic Council Oil and Gas Guidelines, which were adopted and endorsed by the Ministers of the Arctic States, an oil spill response plan should meet a number of detailed requirements, and "*Operators should allow the opportunity for public review and comment of the Plan*".<sup>1</sup>

We understand that this has not yet happened in the case of Cairn Energy's drilling operations this summer. We therefore respectfully request that you ensure that this plan is released and made available for public comment and scrutiny. We are concerned that secrecy and non-compliance with circumpolar agreements on such a vital issue will create a dangerous precedent. Drilling should not commence until the oil spill response plan is disclosed and the public is given an opportunity to provide comments.

To be clear, the information that has been made public through Cairn's Environmental Impact Assessments<sup>2</sup> gives us serious cause for concern. For instance, Cairn has not modeled a spill in ice-bound conditions, looking instead at the impact of a relatively limited leak spilling a small amount of oil during the Arctic summer, when the sea is ice-free. Yet even this modeling shows that spilled oil could reach the boundaries of Arctic sea ice and significantly impact local wildlife. Cairn has even described how a blow-out would have "major negative consequences" for the environment and economy of Greenland, and how fisheries, in particular, would be severely hit. A spill could also seriously impact the Canadian side of Baffin Bay.

Currently Greenland only has the capacity to deal with minor oil spills. For larger oil spills, equipment would need to be shipped in from overseas, which could take weeks. Because response and purification techniques are only effective in the Arctic before oil begins to spread, the first phase of an oil spill clean-up is crucial.

Given these grave concerns, we strongly believe that Cairn's plans for dealing with any potential disaster should be made public, in accordance with Arctic Council Guidelines and normal industry practice, so that those that would be impacted by a spill are able to make up their own mind as to whether their plans are adequate.
