4a (Code: ) (Expenses \$ 4,444,790. including grants of \$ 18,466.) (Revenue \$ ) Climate (Energy & Arctic) - Greenpeace is campaigning for a rapid and just transition to a clean energy economy. Our world is hotter now than it has been in two thousand years and, if current trends continue, by the end of the century the global temperature will likely climb higher than at any time in the past two million years. The Arctic is warming faster than the rest of the globe and is experiencing some of the most severe climate impacts on the planet. In the U.S., coal-fired power plants are the single largest source of global warming pollution. The expansion of U.S. coal exports threatens to become the country's single largest new source of carbon pollution.

4b (Code: ) (Expenses \$ 2,755,598. including grants of \$ 2,188.) (Revenue \$ ) Forests - Greenpeace is campaigning for Zero Deforestation in the world's ancient forests. As much as 80% of the world's forests have been degraded or destroyed. Ancient forests are home to two-thirds of all plant and animal species found on land, and millions of people rely on them for survival. Forests also store vast amounts of carbon in their trees and soil, which is released into the atmosphere when they are burned or cleared. Currently, deforestation is responsible for 10-20% of global greenhouse gas emissions, second only to the fossil fuel sector.

(Revenue \$ ) Oceans - Greenpeace is campaigning for sustainable fisheries and the creation of a network of ocean sanctuaries (marine reserves). Destructive fishing and over fishing are among the most significant threats facing the world's oceans. In addition to wreaking havoc on fish populations, destructive fishing practices harm marine birds and mammals, coastal fishing grounds that many communities rely on, and deep water habitats that are essential for many species to survive.
