Apologies in advance this will be a brief response (I'm on the GW RPS – I've clipped a graph below to illustrate why it's important).

This is the same story we hear year on year:

- I've only skimmed that web page but it looks similar to previous offerings

I'm attaching my analysis of FW2020 which will still be relevant to this latest data – our key message was:

- *It is our strong submission that the reporting agencies have not “nailed” state and trend reporting, to the very significant cost of public and political understanding:*
 - *Currently, state is reported separate to trends; magnitude is not reported at all; and environmental significance is not mentioned*
 - *We strongly endorse the PCE recommendation that the reporting agencies assemble the skills needed to prioritise and interpret the data and research they commission*
 - *This recommendation is especially urgent in the context of the current economic situation which puts a premium on smart, well-targeted investments which deliver for the environment at least cost to the economy*
 - *FFNZ recommend urgent attention to integrated state/trend/magnitude analysis with a specific focus on environmental significance, to yield insights relevant to prioritized policy*
- *FFNZ agree with the PCE that a key question is the extent to which environmental reporting helps us understand and manage our environment in ways that support environmental, social and economic health. It is our strong submission that FW2020 does not meet this test. Instead our assessment is:*
 - *NZ is broadly maintaining current state*
 - *Changes are at the margins relative to previous centuries*
 - *The imperative is to identify and prioritise the outliers (poor state/degrading trends) for action at the appropriate (catchment) scale.*
- *FFNZ welcome the new emphasis in FW2020 on catchments and catchment communities. We agree that most catchments are a mosaic of landuses, that challenges and opportunities are best addressed and progressed in the catchment-specific context, and that “exemplar” and “at risk” catchments should be prioritised for coordinated partnerships and action*

Re lakes:

Re rivers

- Important to be clear that this data is **medians**
- For clarity/e coli and to a lesser extent DRP, it is the 95th % spikes which are principally at issue, principally driven by flood flows
- Then as Colin says, we have tools to dis-aggregate sources, be it sediment sources or e coli sources
- The point is to get a grip on the patterns/sources so we can target the best bang for buck interventions

Re MCI


- I agree this is a key integrative indicator
- See pg 7 on in my report – I'd have to have a proper look at the new data to see if its saying something different (but I doubt it, numbers don't bounce around that much)

Re trends



- Ton Snelder did work looking at what was driving trends
- He couldn't find a direct connect with landuse, eg, heaps of degrading trends in native landcover
- Instead he found a better connect with bigger climate cycles
- I'll separately forward an email re that

Further to what has supplied below, we would also want to see the following highlighted clause from the NBEA included in the RMA (should the NBEA be repealed). As far as I am aware, this is the only clause / section in any of the legislation / regulations that gives a pathway for FWFP to not be compulsory for all “farms” over 20ha.

387Application of this subpart

(1) This subpart applies only—

- (a) to a region, district, or part of New Zealand specified in an Order in Council under this section; and
- (b) on and from the date specified in the Order in Council.

(2) The Governor-General may, by Order in Council, on the recommendation of the Minister, determine—

- (a) that this subpart applies to a specified district, region, or part of New Zealand; and

(b) the date on which this subpart applies to that district, region, or part of New Zealand.

(3) The Governor-General may, by Order in Council on the recommendation of the Minister, in relation to a region, district, or part of New Zealand to which this subpart applies,—

(a) disapply a statutory land use area threshold; or

(b) disapply a statutory land use area threshold and prescribe a higher land use area threshold in its place.

(4) Before making a recommendation under subsection (2) or (3), the Minister must—

(a) be satisfied that the order is necessary to achieve the purpose of this subpart in the specified district, region, or part of New Zealand; and

(b) consult the Minister of Agriculture.

(5) An order under this section is secondary legislation (see [Part 3](#) of the Legislation Act 2019 for publication requirements).

In respect of changes to the RMA we discussed, I've set out below the two things I think we could get changed right now. If it would be helpful, I could put the wording below into a word document ...

1. Changing dates

The government has indicated that it will change the date in section 80A of the RMA for notification of planning instruments to give effect to the NPSFM to 31 December 2027.

A concern we have is that councils will continue to progress their plan changes, particularly because clause 4.1 of the NPSFM says that they must give effect to the NPSFM “as soon as reasonably practicable.”

There does not appear to be an easy solution for changing how this is interpreted through an amendment to section 80A. The only solution I can think of is that at the same time the date in section 80A is amended, some additional wording is included along the lines of “and as soon as reasonably practicable is to be interpreted in light of this date.”

Below is the relevant subsection and how it could possibly be changed (amendments in red):

(4)

A regional council must—

(a)

publicly notify the freshwater planning instrument; and

(b)

if the purpose of the freshwater planning instrument is to give effect to the National Policy Statement for Freshwater Management 2020, publicly notify the freshwater planning instrument by 31 December ~~2024~~2027, with “as soon as reasonably practicable” to be interpreted in light of this timeframe; and

(c)

no later than 6 months after it has publicly notified the freshwater planning instrument, submit the documents required by [clause 37\(1\)](#) of Schedule 1 (the

required documents

) to the Chief Freshwater Commissioner; and

(d)

at least 20 working days before submitting the required documents, provide to the Chief Freshwater Commissioner in writing—

(i)

its notice of intention to submit those documents; and

(ii)

the regional council and local tangata whenua nominations for appointment to the freshwater hearings panel required by [clause 59\(1\)\(b\) and \(c\)](#) of Schedule 1.

2. Freshwater farm plans

A significant issue with the freshwater farm plans is that many councils are interpreting the law as saying that they cannot have discretionary farm plans as a permitted activity (due to issues with the need for certainty and unlawful delegation of council discretion).

If freshwater farm plans were able to be incorporated into regional plan rules as a permitted activity tool for managing effects, that would make a big difference for farmers (who are concerned about the cost and time involved in a resource consent, which is unlikely to add any additional rigour over what the certified farm planner has required in the freshwater farm plan).

This could be addressed by an amendment to section 217L of the RMA as follows:

217L Relationship between certified freshwater farm plan and specified instruments

(1)

A certified freshwater farm plan may contain a requirement that—

(a)
relates to an activity carried out on the farm (an **activity**
) even if there is no similar requirement relating to that activity in a provision of a specified instrument:

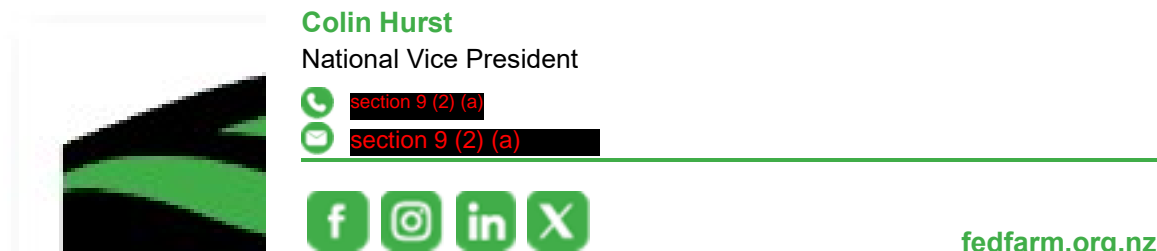

restricts an activity more than a provision of a specified instrument.

However, if a provision of a specified instrument restricts an activity more than a requirement of a freshwater farm plan, the provision of the specified instrument prevails.

To avoid doubt, compliance with a requirement of a certified freshwater farm plan—

(a)
does not of itself authorise a person to undertake an activity:

(b)
may be specified or included as a requirement or condition in any specified instrument relating to an activity including as part of a permitted activity rule.

Hi section 9 (2) (a),

Hope you are both well.

Wayne Langford, Federated Farmers President, and Colin Hurst, Federated Farmers Vice President and Freshwater Spokesperson are both in Wellington on the 30th and 31st of January to attend some of the parliamentary maiden speeches.

This could be a good opportunity to meet with Todd and Andrew, alongside Minister Symonds, if possible, to further build the relationship between Government and Feds and discuss some of the broader agricultural issues on the horizon. Three key topics could be:

- **Freshwater Farm Plans.** Both coalition agreements discuss potential changes to Freshwater Farm Plans. However, councils are continuing to roll out Freshwater Farm Plans. Farmers are also facing uncertainty on if they should spend money on a Freshwater Farm Plan under the current regulations or wait for rules to be reviewed. It would be good to discuss the Government's plans for Freshwater Farm Plans and what our messaging to farmers should be. Note Federated Farmers supports the Government position of amending (rather than repealing) Freshwater Farm Plans. We can discuss with you the details of our position.
- **Changes to National Environmental Standard for Freshwater:** Changes are needed to farming regulations relating to winter grazing, wetlands, stock exclusion, etc. These changes were signalled prior to the election by the political parties which formed government. We are interested to understand what is planned in this area and share our thoughts with you.
- **Unlocking water storage:** The NZ First Coalition agreement discusses cutting red tape and regulatory blocks on irrigation, water storage, managed aquifer recharge and flood protection schemes. As with above, we are eager to understand timelines for this work and how we can input.

Would Ministers McClay, Hoggard and Symonds be available for a meeting to discuss these topics?

We acknowledge the incoming Government's recognition of the need for urgent action to support the primary sector, and we are encouraged by its commitment to reducing barriers and costs across the sector and reflecting the world leading status of our agricultural producers.

Key issues for farming in your portfolio

Biosecurity is critically important to our primary industries. An unwanted pest or disease such as Foot and Mouth Disease, would have a huge impact on agriculture, our regional economies, the national economy, and natural and urban environments. It's important to have the right measures in place to prepare, respond to and, if needed, manage on an on-going basis pest or disease incursions.

Re: Marlborough's Lack of Soil Moisture

At the general meeting of Marlborough Federated Farmers of NZ on 1st February 2024, members expressed their concern over soil moisture deficits. The deficit started much earlier this season. Marlborough has dipped below zero on water balance in early September - almost a month earlier than the 2014 and 2015 droughts, and well before our long-term average of moisture deficit in late October.

If the lack of rain continues during February, (which would be the norm) and with strong wind and high temperatures farmers will be pushed into a drought situation across Marlborough. There are already localised areas with extreme dry, where farmers are feeding out reserves normally kept for the winter months. Those farmers who have sold all trading livestock may be looking at selling capital livestock shortly as well.

Marlborough Federated Farmers wish to advise that the situation is being reviewed on the 14th February, and a more formal call for a medium scale event may be called for.
