Dear Russel

Thank you for your email of 2 October 2025 requesting the following under the Official Information Act 1982 (the Act):

I was following up your statements in this story - https://www.rnz.co.nz/news/political/574719/environment-minister-accused-of-using-position-to-influence-council-s-legal-process Can you please tell me under the OIA:

- 1. How many regional councils have you written to since you've been a Minister, regarding the granting of resource consents to particular businesses. Please provide copies of all these letters or emails.
- 2. What correspondence have you received in response to these letters or email? Please provide copies of all these letters or emails.
- 3. Do you now accept that Horizons Regional Council was correct in its handling of the particular consent applications referenced in the RNZ story linked above? If so why? If not why not?

I have identified nine items in scope of parts one and two of your request, as listed in the attached document schedule. I am releasing these nine items to you in full. Furthermore, I have identified and included an additional four items. These are emails/letters that were recently sent to all regional and unitary councils. These were not considered to be in-scope of your original request as they do not relate to "particular businesses", however they may be of interest as they relate to "granting of resource consents" more generally. A copy of this letter can be found here: Letter to Regional Council Chairs and Chief Executives. Please note an identical letter was sent to Unitary Council Chairs and Chief Executives.

Note that your request has been interpreted as how many regional councils that I have written to "regarding the granting of resource consents to particular businesses". Please be advised that I write to regional councils on a wide range of matters that were not considered as in-scope of this request.

Regarding the third part of your request, following receipt of the letter from farmers in the Santoft area, the Minister of Agriculture, Hon Todd McClay, the Associate Minister for the Environment, Hon Andrew Hoggard, and I met with the farmers to better understand their concerns and the steps they have taken towards progressing their applications for replacement consents.

I wrote to the Council to seek their views, as well as to understand what could be done to achieve a timely solution for the affected farmers, particularly given the Government's commitment to helping the primary sector grow New Zealand's economy.

While appropriately addressing environmental matters, I am confident that the Council and the farmers will be able to work together to achieve a resolution that supports the continued viability of farming in the region.

You have the right to seek an investigation and review by the Office of the Ombudsman of my decisions relating to this request, in accordance with section 28(3) of the Act. The relevant details can be found at: www.ombudsman.parliament.nz.
