Subject: Notice of Inquiry Commencement

Thank you for contacting the Competition Bureau (the "**Bureau**") and submitting an application for consideration under section 9 of the *Competition Act* (the "**Act**") that was received on <u>March 15, 2023</u>.

The Bureau takes all allegations of anti-competitive conduct and deceptive marketing practices very seriously. Further, the role of the Bureau, as an independent law enforcement agency, is to ensure that Canadian businesses and consumers prosper in a competitive and innovative marketplace.

In carrying out our mandate, the information brought to our attention by consumers, businesses and other market participants is very important as it contributes to the identification and analysis of potentially anti-competitive practices in the marketplace.

I therefore wish to inform you that the Commissioner of Competition has commenced a formal inquiry pursuant to paragraph 10(1)(a) and under paragraph 74.01(1)(a) of the Act into certain marketing practices of Pathways Alliance (the "**Inquiry**"). Specifically, the Inquiry seeks to determine the facts relating to allegations that the Pathways Alliance has contravened the Act by making false or misleading environmental representations.
