Please find below a Policy for Association complaint submission related to Paper Excellence's links with Asia Pulp & Paper and the Sinar Mas Group. We expect the FSC to accept this complaint and initiate an investigation based on it meeting the following requirements per section 2.12 of the FSC Policy for Association Complaint Procedure (FSC-PRO-01-009):

- 1) all required information in the complaint submission form is provided;
- 2) there is substantial information to warrant a full evaluation; and
- 3) the complaint falls within the scope of the FSC Policy for Association.

We note that this complaint addresses issues that pose significant risk to the FSC's reputation, and as such we make the following requests aligned with the FSC's aim to "address formal complaints of violations to the FSC Policy for Association in a timely, independent and effective manner" per FSC-PRO-01-009.

- We expect to receive a time-bound commitment from the FSC on conducting an investigation and making a decision based on that investigation.
- We expect the FSC to appoint an independent investigator specializing in financial issues to conduct an investigation of beneficial ownership.
- We expect the FSC to share the Terms of Reference for the expert conducting the investigation.
- We request that independent observers are included in the investigation.
- We request the FSC to fully explain its rationale for any decision.
- We retain the right to update this complaint with additional evidence if it comes to light before the FSC announces a decision.

## Information to be submitted for a Policy for Association Complaint

## Objective of the complaint

In accordance with the FSC's Policy for Association (PfA) related to "indirect involvement" (PfA version 2), this complaint seeks to extend the scope of Asia Pulp & Paper's disassociation to Paper Excellence and its affiliates based on new evidence in the public domain.

## Specification of the issues and events that led to the complaint

Paper Excellence was reportedly established in 2006 and has its corporate headquarters in British Columbia, Canada.<sup>1</sup> Over the past 15 years, Paper Excellence has carried out an ambitious strategy of corporate acquisitions to emerge as one of the largest pulp and paper producers in North and South America.<sup>2</sup> In 2021, Paper Excellence acquired one of North America's largest pulp and paper producers, Domtar Corporation, for US\$3.0 billion<sup>3</sup>, and in 2023 it completed the acquisition of Resolute Forest Products, a major North American producer of pulp, paper, and lumber, for a reported US\$2.7 billion.<sup>4</sup>

As of October 2023, Paper Excellence owns 42 pulp, paper, and/or lumber mills with Forest Stewardship Council (FSC) certification (see Appendix A). Paper Excellence and its affiliates

manage 22 million hectares of forest, according to reporting in June 2023.<sup>5</sup> Five forestry management units with a licensed area totaling 7.3 million hectares currently have certification from the FSC (see Appendix A).

Asia Pulp & Paper (APP), a company under common control with Paper Excellence,<sup>6</sup> is currently proscribed from membership to the FSC because of "destructive forestry practices."<sup>7</sup> Since the 1990s, APP has been responsible for extensive deforestation in Indonesia<sup>8</sup> and has been involved in a multitude of conflicts with rural and Indigenous communities living in and around its forestry concessions, according to numerous NGO and media reports.<sup>9</sup> A 2010 report by Eyes

on the Forest estimated that APP was responsible for deforestation of an area greater than two million hectares, including Sumatran tiger and orangutan habitat, in the provinces of Riau and Jambi, Indonesia between 1984 and 2010. Despite APP's 2013 Forest Conservation Policy, which included a commitment to "zero-deforestation" in the group's supply chain, deforestation has continued during the years since, albeit at lower rates. A 2018 Greenpeace Indonesia study revealed that from 2013 to 2018, almost 8,000 hectares of forest and peatland were cleared in two concessions linked to APP and its parent entity, the Sinar Mas Group. Reenpeace said in October 2023 that APP is "still linked to deforestation" while publishing a report that noted "Based on Nusantara Atlas analysis using University of Maryland forest loss data, between 2013 and 2022, there was a total of 74,873 hectares of deforestation in APP Sinarmas supplier concessions."

In 2007 the FSC disassociated from APP in response to a Policy for Association complaint from environmental organizations, including Greenpeace International, over APP's role in industrial-scale deforestation.<sup>15</sup> In December 2007 the FSC released a statement that said:

The Forest Stewardship Council dissociated from working with Indonesian based Asia Pulp and Paper (APP) in October 2007. The Forest Stewardship Council has a duty to protect the good will and integrity associated with its name and logo for consumers and for our trusted partners and members. The FSC Board of Directors decided that association with APP would threaten the good will and faith invested in the name Forest Stewardship Council and the years of support and participation by companies that are truly committed to the pursuit of responsible forest management globally.<sup>16</sup>

The FSC initially stated that the scope of its decision would apply only to companies for which APP was the majority owner.<sup>17</sup> In 2009, the FSC adopted Version 2 of its Policy for Association (PfA v2), which identifies the kinds of corporate relationships that define the scope of corporate responsibility for destructive forestry practices.<sup>18</sup> Specifically, sister, parent, subsidiary, shareholder, and Board of Director relationships qualify as "indirect involvement" in destructive forestry practices per PfA v2.

The FSC stated in a media report in May 2023 that it undertook multiple evaluations of Paper Excellence's connections with APP, most recently in 2021.<sup>19</sup> The FSC assessments apparently did not find that Paper Excellence met the criteria for "indirect involvement".<sup>20</sup>

Since the most recent review of Paper Excellence by the FSC took place in 2021, an NGO report and multiple media investigations have been published containing substantial new information about the relationship between Paper Excellence and APP that previously was not in the public domain. Canada's Minister of International Trade even referred to Paper Excellence as Sinar Mas in 2021,<sup>21</sup> and in May 2023 the House of Commons Standing Committee on Natural Resources initiated an investigation into Paper Excellence's connections to APP and Sinar Mas.<sup>22</sup> Given these developments, it is imperative that FSC re-examine the relationship between Paper Excellence and APP to determine if Paper Excellence is eligible to retain membership in the FSC. The issue is even more urgent because Paper Excellence is currently represented on the FSC Canada Board of Directors via its Resolute Forest Products company.<sup>23</sup>

Below is a timeline of relevant events that led to the complaint:

- January 2007. The Meadow Lake Mechanical Pulp Mill in Saskatchewan, Canada, is purchased by a company "indirectly related to the Sinar Mas companies", according to a press release issued by Sinar Mas at the time.<sup>24</sup>
- October 2007. The FSC disassociates with APP over "destructive forestry practices".<sup>25</sup>
- November 6, 2007. The FSC certificate for Paper Excellence's first mill acquisition in Canada, Meadow Lake Mechanical Pulp Mill, is issued.<sup>26</sup>
- November 7, 2007. As a result of the disassociation with APP, FSC terminates the certificates for PT Pabrik Kertas Tjiwi Kimia Tbk., an APP paper company in Indonesia, and five APP China mills.<sup>27</sup>
- July 2009. The FSC adopts 'Part I' of Policy for Association Version 2, which establishes
  the criteria for "indirect involvement" with an organization involved in unacceptable
  activities.<sup>28</sup>
- March 31, 2010. A numbered corporation is incorporated in Canada (0877457 B.C. Ltd)<sup>29</sup>, which changes its name to Paper Excellence Canada Holdings Corporation on April 10, 2010.<sup>30</sup>
- October 2010. The Meadow Lake Mechanical Pulp Mill switches its letterhead from "A division of Sinarmas Group" to "Paper Excellence Group".<sup>31</sup>

- April, May, July 2010. Paper Excellence acquires four more mills: two in Canada and two in France.<sup>32</sup> All obtain certifications from the FSC.<sup>33</sup>
- July 2010. Greenpeace International publishes Pulping the Planet showing "that APP continues to acquire and destroy rainforest and peatland to feed its two pulp mills in Sumatra."34
- October 2013. The FSC states, "During this period FSC will not pursue any extension of disassociation from other companies allegedly related to APP. This will remain the situation until the FSC Board reaches a conclusion on whether or not to consider re-association with APP, provisionally scheduled for the first half of 2014."35
- July 2018. The FSC states, "Any company in the APP Group directly or indirectly involved in the unacceptable activities as defined by the FSC Policy for Association is subject to the scope of disassociation and not permitted to use the FSC trademarks."36
- August 2018. The FSC suspends the roadmap process with APP following media and NGO investigations documenting Sinar Mas Group and APP's use of an opaque corporate structure to disguise its connections to at least 25 wood supply companies that APP had declared were independently owned and operated.<sup>37</sup>
- October 2019. Auriga Nusantara, an NGO based in Jakarta, Indonesia, sends a letter to the FSC's Director General and Chair of the FSC International Board with evidence in the form of an audited Bond Prospectus showing that Paper Excellence's reported

owner, Jackson Wijaya, is a Director and Assistant President of a holding company for all of APP China's mills.<sup>38</sup>

- July 2020. The FSC Director General Kim Carstensen responds to the October 2019
  letter from Auriga Nusantara by indicating that the evidence shared "would qualify Paper
  Excellence as being indirectly involved with an indirectly involved organization. With this,
  we have found Jackson Widjaya [sic] positioned one degree removed from the
  disassociated group."<sup>39</sup> (See Appendix B for the full letter.)
- April 2021. Canadian Minister of International Trade and Economic Development Mary Ng refers to Paper Excellence as "Sinar Mas from Indonesia" in the House of Commons.<sup>40</sup>
- December 2021. Paper Excellence purchases Domtar, a U.S. and Canada-based integrated wood products company<sup>41</sup> that has 11 pulp and/or paper mills and 8 converting facilities with FSC certification (see Appendix A).<sup>42</sup> A representative of Domtar was an FSC Canada Board Member during 2020-2021.<sup>43</sup>
- October 2022. A coalition of NGOs Greenpeace Canada, Rainforest Action Network, Environmental Paper Network, and Woods & Wayside International – publishes a detailed investigative report on the links between Paper Excellence and APP.<sup>44</sup>
- December 2022. The FSC adopts version 3 of its Policy for Association (PfA v3) that applies the definition of corporate group from the Accountability Framework Initiative (AFI), which explicitly recognizes forms of control beyond legal ownership. The new policy applies to practices deemed to be in violation of FSC standards that have occurred after January 1, 2023.<sup>45</sup>

- March 2023: Paper Excellence finalizes a deal to purchase Resolute Forest Products<sup>46</sup>, an FSC Canada board member<sup>47</sup>, which has 24 pulp, paper, and/or lumber mills and 7.1 million ha of forest with FSC certification (see Appendix A).
- March 2023. A collaborative media investigation led by the International Consortium of Investigative Journalists (ICIJ) called *Deforestation Inc.* publishes a series of articles about Paper Excellence and its connections to APP and Sinar Mas.<sup>48</sup>
- May-June 2023. The Canadian Parliament's Standing Committee on Natural Resources holds three hearings on Paper Excellence's ownership structure and business practices.<sup>49</sup> Paper Excellence's reported owner Jackson Wijaya is requested to testify, but does not appear before the Parliament went into Summer recess.<sup>50</sup>
- October 2023. Paper Excellence declines the invitation from the Canadian House of Common's Standing Committee on Natural Resources for Paper Excellence's reported owner Jackson Wijaya to testify.<sup>51</sup>

# <u>Please indicate which activities unacceptable under the PfA are the subject of this complaint</u>

- Destruction of high conservation values in forestry operations
- Significant conversion of forests to plantations or non-forest use

### Evidence to support each aspect of the complaint

The following information pertains to Paper Excellence's relationship with Sinar Mas and APP. It is divided into the following sections:

- Ownership and family ties

- Official government documents and proceedings
- Scope of "indirect involvement" (PfA v2) and "corporate group" (PfA v3)

### Ownership and family ties

Jackson Wijaya is Paper Excellence's reported owner, and he is the son of APP's Chairman and shareholder Teguh Ganda Widjaja. International Financial Reporting Standards (IFRS) and other accounting standards recognize close family relationships such as parent/child and siblings in the guidance for determining "related parties". <sup>52</sup> Jackson Wijaya is the brother of Linda Wijaya Limantara, a former managing director of APP. <sup>53</sup> Linda Wijaya Limantara was, until October 2022, also a shareholder in PT Purinusa Ekapersada <sup>54</sup>, which holds controlling interests in APP's major pulp and paper mills in Indonesia. <sup>55</sup> Three of Jackson Wijaya's uncles – Indra Widjaja, Franky Widjaja, and Muktar Widjaja – until recently held similar interests in PT

Purinusa Ekapersada.<sup>56</sup> Jackson's grandfather, Eka Tjipta Widjaja, who died in 2019, was the founder of the Sinar Mas Group.

According to Linda Wijaya Limantara quoted in a 2019 article published in The Nikkei, a financial newspaper, Sinar Mas operates "like a family council" even as only one family member is appointed to manage each company.<sup>57</sup> In response to this finding of extensive family connections between Sinar Mas and Paper Excellence, Graham Kissack of Paper Excellence stated, "Of course, it is well known that Jackson Wijaya, the ultimate owner of PE [Paper Excellence], is the son of the current leader of APP/SMG. But Jackson continues to operate PE completely independently."58

Until at least 2017, Jackson Wijaya held key management positions in APP China for more than a decade while his father Teguh Ganda Widjaja was the top executive. Jackson Wijaya started working at APP China at the age of 22 in 2002 "to set up the business enhancement team which implements managerial reforms in major production plants of the Group in the PRC [People's Republic of China]", according to an APP China prospectus for a debt issuance in Hong Kong.<sup>59</sup> Three years later, in 2005, Jackson Wijaya reportedly became director for APP China "where he assisted the Chairman [Jackson's father Teguh Ganda Widjaja, Chairman of APP] with the management of the Group's [Ever Dragon Investments, APP China's holding company] PRC [China] business,"60. (See Appendix C for description of the positions that Jackson Wijaya has held at APP China, as summarized in a 2017 Ever Dragon Investments prospectus for a bond issuance in Hong Kong.)

Based on Jackson's reported history with APP China, Jackson Wijaya was director of APP China when Paper Excellence acquired its first mill in 2007. He served as a Director for APP China for over a decade<sup>61</sup> as Paper Excellence continued to acquire mills in Canada and France. In September 2017, at which time Paper Excellence owned seven mills in Canada and two mills in France, Jackson Wijaya was Assistant President of APP China, second in company

rank only to his father, Teguh Ganda Widjaja, Chairman of APP.<sup>62</sup> In his official management capacity, Jackson Wijaya had a fiduciary duty to APP China and was a subordinate to his father, the Chairman of APP, at the same time as he was reportedly Paper Excellence's sole owner, operating Paper Excellence, according to the company, "completely independently".<sup>63</sup>

Teguh Ganda Widjaja, Jackson Wijaya's father and APP's Chairman, served as director of Paper Excellence's ultimate parent company in 2009. As of December 31, 2009, Paper Excellence's ultimate parent company was Marque Technologies Limited, incorporated in the British Virgin Islands.<sup>64</sup> Marque Technologies Limited was established in 1996, and for several years before Paper Excellence was founded, its directors included APP's Chairman, Teguh Ganda Widjaja, and APP's Chief Financial Officer, Hendrik Tee.<sup>65</sup>

According to the Offshore Leaks published by the International Center for Investigative Journalism, the only director of Marque Technologies as of 2010<sup>66</sup> was the Chairman of APP, Teguh Ganda Widjaja (the other directors stopped serving in 1998 and 2002).<sup>67</sup> The shareholder of Marque Technologies as of 2010, according to Offshore Leaks, was one bearer share.<sup>68</sup> A bearer share is owned by whomever physically possesses the shares certificate, as opposed to registered or named shares.<sup>69</sup> Marque Technologies Limited was at that time in 2009 (and remains as of August 2022) a minority shareholder of PT Purinusa Ekapersada, through which it owns shares of all APP mills in Indonesia.<sup>70</sup>

Multiple accounts by former APP staff indicate that Teguh Ganda Widjaja was involved in key decision-making for Paper Excellence. *Radio France* reported in March 2023 that a former

senior executive of Fibre Excellence, Paper Excellence's subsidiary in France, saw Teguh Widjaja several times in Vancouver and Shanghai and describes him as being directly involved in the decisions taken by the group. <sup>71</sup> *Le Monde* reported a comment from apparently the same former executive of Fibre Excellence: "I was directly connected with the owners of APP. My boss at the time was based in China and monthly video conference meetings were held with Teguh Widjaja." <sup>72</sup>

The Canadian Broadcast Corporation (CBC) reported in May 2023, "After CBC and its partners published their initial investigations into Paper Excellence in March, someone who worked at APP in the mid-2010s reached out to speak about his experiences at the company. He told CBC he observed that strategic decisions on things like Paper Excellence's next acquisitions came from Teguh Wijaya, Jackson's father."<sup>73</sup>

In statements to the media, Paper Excellence has claimed Jackson Wijaya is its sole owner.<sup>74</sup> But in disclosures in filings to the U.S. Securities and Exchange Commission (SEC), for which it can be held legally accountable, Paper Excellence has stated that Jackson Wijaya's ownership should be understood to potentially include other family members. In Domtar Corporation's 2022 filings to the SEC following its acquisition by Paper Excellence, Exhibits 4.1, 4.2, and 4.3 to the original 10-K submission document Domtar's financing arrangements. All three exhibits state in their respective sections on "definitions" that:

Jackson Wijaya means (a) Jackson Wijaya, (b) family members of Jackson Wijaya, (c) trusts, partnerships or limited liability companies for the benefit of any of the individuals identified in the foregoing clause (a) or (b), and (d) heirs, executors, estates, successors and legal representatives of the individuals identified in the foregoing clause (a) or (b).<sup>75</sup>

According to this statement, other members of the Widjaja family may benefit from and/or control Paper Excellence with or without the involvement of Jackson Wijaya, the natural person.

#### Overlapping key management personnel

Several of APP's senior executives held positions as top company officials in Paper Excellence companies while at the same time employed as executives for APP.<sup>76</sup> These include Suresh Kilam<sup>77</sup>, Tei Ah Lek<sup>78</sup>, Hardi Wardhana<sup>79</sup>, and Danilo Benvenuti<sup>80</sup>, as documented in the October 2022 NGO report.<sup>81</sup>

#### Suresh Kilam

Suresh Kilam was director of APP's Indonesia mills, and he concurrently served as director of a Paper Excellence holding company for eleven years between 2007 and 2018. Until March 2018, Suresh Kilam was director of Fortune Everrich Sdn. Bhd.<sup>82</sup>, the Malaysian parent company of

Paper Excellence B.V.<sup>83</sup> While he was director of Fortune Everrich Sdn. Bhd., Suresh Kilam was also director of major APP pulp and paper mills in Indonesia: PT Indah Kiat Pulp & Paper, PT Lontar Papyrus Pulp & Paper, PT Tjiwi Kima, and PT Pindo Deli.<sup>84</sup> He has held key management positions in the holding companies for APP mills and other companies as director of PT Purinusa Ekapersada<sup>85</sup> and Asia Pulp & Paper Co, another holding company for APP mills in Indonesia that is incorporated in Singapore.<sup>86</sup>

#### Tei Ah Lek

Tei Ah Lek was director of APP China companies while concurrently serving as director of Fortune Everrich, the parent company of Paper Excellence B.V. Tei Ah Lek was Fortune Everrich's director between 2004 and 2018.<sup>87</sup> During some of the time he was director of Fortune Everrich, Tei Ah Lek was also the Chief Financial Officer and general manager of investments for Sinar Mas Paper (China) Investment Corporation, which wholly owns all seven of APP's mills in China.<sup>88</sup> His direct superior at Sinar Mas Paper (China) is the longtime Chairman of APP, Teguh Ganda Widjaja.<sup>89</sup>

Hardi Wardhana, aka Peter Wardhana, is a long-time director of Paper Excellence companies<sup>90</sup>. According to a March 2023 filing to the SEC, Hardi Wardhana is one of three directors of the Paper Excellence Group and is "Global Head of M&A" [mergers and acquisitions].<sup>91</sup> His address on official corporate registry documents<sup>92</sup> submitted to the Government of Canada as early as November 2010<sup>93</sup> and as late as October 2018<sup>94</sup> matches the official address at Sinar Mas headquarters in Jakarta used by PT Indah Kiat Pulp & Paper, one of APP's flagship pulp and paper companies in Indonesia, and other APP businesses during that same time period: Plaza BII, Tower II, 7th Floor, JI Thamrin No. 51 Jakarta Pusat 10350 Indonesia.<sup>95</sup> Plaza BII, now called Sinar Mas Land Plaza, is the headquarters of Sinar Mas and APP in Indonesia.

#### Danilo Benvenuti

Danilo Benvenuti served as director between 2010 and April 26, 2018 for Fibre Excellence SAS, the company that owns two pulp mills that Paper Excellence acquired in France in 2010.<sup>96</sup> Danilo Benvenuti has also served for over two decades as an APP executive in Europe and, at least since 2014, as APP's regional director of sales for Europe.<sup>97</sup> During the same period that he was director of Fibre Excellence SAS, Danilo Benvenuti was director of Asia Pulp & Paper

(Germany) BmbH,<sup>98</sup> Asia Pulp & Paper Italia SRL<sup>99</sup>, and Asia Pulp & Paper France EURL (see Figure 20).<sup>100</sup>

#### **APP staff involvement in Paper Excellence**

The family and management ties between Paper Excellence and APP described above were reportedly reflected at the operational level as well. According to leaked email communications between APP and Paper Excellence staff members, APP staff were involved with Paper Excellence's operations and decision making. Multiple former employees corroborated APP's involvement with Paper Excellence's business activities, according to investigative reports by Canadian and French media.

The Canadian Broadcasting Corporation (CBC) published an investigation in March 2023, alongside investigative reports by other media outlets. The investigation "found leaked records and insider accounts that show that Paper Excellence, at least until a few years ago, appears to have been closely – and secretly – coordinating business and strategy decisions with Asia Pulp & Paper, one of the world's biggest pulp-and-paper players, which has a track record of environmental destruction."<sup>101</sup>

Glacier Media, which publishes a number of regional newspapers in British Columbia reported:

According to former employees [of Paper Excellence] and leaked communications, the Canadian offices have at times seemed to function as little more than a shell for work handled overseas by Asia Pulp and Paper (APP), the forestry arm of the Sinar Mas Group [...]

Leaked emails show APP employees helped guide Paper Excellence's application to Chinese regulators in 2017 and 2018, during its initial planned takeover of the Eldorado mill in Brazil.

One former middle manager at APP said Paper Excellence executives would regularly go back and forth between Canada and APP's Shanghai offices.

"They would come to China and we would discuss strategy with them," said the former employee, who spoke to Glacier Media on condition of anonymity. "It was all part of the game. We were all incestuous over there."

Emails show senior staff from APP and Paper Excellence worked together to build market forecasts, prepare answers for China's anti-trust regulator and arrange Canadian pulp shipments directly to supply APP mills.

In one September 2017 exchange, Paper Excellence's vice-president of pulp sales Edwin Widjaja provides APP deputy general manager Richard Pho with a five-year pulp price forecast. In another, Pho tells his Paper Excellence counterpart to stockpile warehouses with FSC-certified North American pulp for their Indonesian "sister mills."

Pho writes "...don't sell anything yet."

"I am holding all offers now," responds Widjaja. 102

The French newspaper *Le Monde*, also in the media collaboration, reported that its investigation "documented the cases of 13 individuals who served in both groups simultaneously." The *Le Monde* report quoted the whistleblower, who reportedly worked at APP as a chief analyst in the 2010s and left the company in 2018:

'We were basically strategically looking after the interests of both companies, Asia Pulp & Paper and Paper Excellence,' he told *Le Monde*, speaking on condition of anonymity. The APP building in Shanghai where he was working at the time, was also home to the 'real brains' of Paper Excellence. 'I would attend the same meetings (...) We would share emails together. I would go to Vancouver [where Paper Excellence is headquartered],' he said, adding Paper Excellence staff asked him for help on pricing issues.<sup>103</sup>

The *CBC*, who interviewed the same whistleblower, reported:

The source said that, in fact, Paper Excellence's entire back office at the time — the teams handling legal, accounting, finance and market analysis — was run by APP and there were no boundaries between staff working for one or the other company.

"APP staff is PE staff. There is no difference there," the source said. 104

In its analysis of the leaked emails between APP and Paper Excellence employees, the *CBC* reported, "APP's outside lawyers and in-house legal department stickhandled submissions to Chinese antitrust authorities when Paper Excellence wanted to buy the Eldorado pulp mill in

south central Brazil; ironically, the drafts even went so far as to list APP as a Paper Excellence competitor."

Two months later, in May 2023, the *CBC* reported that a former employee of APP in the mid 2010s who reached out to them following the publication of their investigation "said Jackson still managed the company day to day, but from APP's offices in Shanghai, with resources and staffing from APP."<sup>105</sup> The *CBC* report explained:

Emails provided by the source show APP and Paper Excellence even sometimes collaborated on hiring. In a 2013 email chain among hiring managers for the two companies, around 140 candidates for jobs at an APP construction project in Indonesia were also offered to Paper Excellence to fill positions in Canada, with an APP executive volunteering to send along their resumés to Paper Excellence's HR manager.<sup>106</sup>

Glacier Media reported another instance of APP's collaboration with Paper Excellence:

One former employee, who asked to remain anonymous, said he was recruited by Paper Excellence from India, sent to APP facilities in Indonesia for several months for training and company "indoctrination," and then flown to work at a Paper Excellence pulp and paper mill in British Columbia. <sup>107</sup>

#### Self-representation about the relationship

Paper Excellence reports that it began operating in 2007 when it acquired the Meadow Lake Mechanical Pulp mill in Saskatchewan, Canada. The press release announcing the acquisition of the Meadow Lake pulp mill on January 18, 2007 states, "The Purchaser [Meadow Lake Mechanical Pulp Inc.] is indirectly related to the Sinar Mas companies. It is anticipated that the Sinar Mas Pulp and Paper Products division ("APP") will be providing technical expertise to the Purchaser in respect of future operations of the Meadow Lake Pulp Mill.[. . .] The Purchaser is excited about the opportunity of being able to expand its worldwide operations into Northern Saskatchewan and Canada." 108

The press release was apparently issued by Sinar Mas: The middle section of the press release appears under the header "About Sinar Mas", and it includes descriptions of Sinar Mas, APP,

and Sinar Mas Forestry (see Appendix D).<sup>109</sup> The bottom section of the press release lists APP's accomplishments and commitments on sustainability and respect for indigenous communities, ending with the statement: "To date, APP and Sinar Mas operations directly and indirectly support millions of families, most of whom live in remote villages and rural communities."<sup>110</sup>

In line with the press release by Sinar Mas, national and local media outlets reported that Sinar Mas and APP purchased the Meadow Lake pulp mill. The headline of a CBC article on December 15, 2006 read, "Meadow Lake mill sold to Indonesian company." The article reported, "On Friday, a spokesman for the mill announced that a major international pulp and paper company based in Indonesia has bought the plant for C\$37 million." The article concludes with, "The purchase is by a company called Sinar Mas Group, which owns Asia Pulp and Paper."

*CBC* reported in May 2023, "The company's oldest holding in Canada, the mill at Meadow Lake, Sask., was actually purchased through a British Virgin Islands-registered corporation in 2007. Until at least 2010, it operated under the Sinar Mas banner."

After the purchase of the Meadow Lake mill was complete, the report in Saskatchewan's local media on January 25, 2007, stated, "The \$38-million purchase of the mill's fixed and operating assets by a subsidiary of Asian forest product giant Sinar Mas – approved by a Court of Queen's Bench judge nearly two weeks ago – became official on Wednesday." The report went on to note, "Vern Bachiu, director of planning and development for the Meadow Lake Tribal Council, said council members met briefly with a representative of Sinar Mas last week."

From 2008 until at least April 2010, the Meadow Lake mill included on its letterhead that it was a "Division of Sinarmas", including on six letters it sent to an environmental regulator in Saskatchewan. (See Appendix E for two examples of these letters.) By October 2010, the Meadow Lake mill's letterhead switched to include Paper Excellence's logo (see Appendix E for an example of a letter from October 2010).

In May 2023, Jean-Francois Guillot, CEO of Paper Excellence's French operations and two mills in Canada, appearing before a Canadian Parliamentary committee, testified, "I'd like to remind committee members that we don't deny the fact that, in its early days, Paper Excellence received help from APP Sinar Mas. However, I would reiterate that this support has been terminated. The last form of support, which was from the Bank of China, was terminated in

2020."<sup>114</sup> *Glacier Media* reported on Guillot having "initially acknowledged Paper Excellence and APP – including the parent Sinar Mas Group run by Wijaya's father – were linked as late as 2020, but later said he misspoke and said ties ended in 2015."<sup>115</sup>

#### Financial details

Paper Excellence's direct financial connection to Sinar Mas is evident in Paper Excellence's early financing arrangements. In 2010, a bank in China owned by Sinar Mas<sup>116</sup> made a US\$17.5 million loan to Paper Excellence at a near-zero percent interest rate.<sup>117</sup> In 2011, Paper Excellence B.V. reported in its Annual Report that the "shareholder loan" of US\$17 million in 2010 increased to US\$70 million as of December 31, 2011.<sup>118</sup>

On the investment side, Paper Excellence B.V.'s financial reports between 2010 and 2014 filed with the Dutch financial authority report accummulated shareholder investment in the form of share premium of US\$788 million.<sup>119</sup> It is unclear whether this shareholder investment is part of the "help from APP Sinar Mas" that Paper Excellence executive Jean-Francois Guillot described to a Canadian Parliamentary committee was provided in the "early days" of Paper Excellence. Guillot's admission to Canada Parliament's Standing Committee on Natural Resources raises questions about whether Paper Excellence's initial investment of close to US\$800 million came solely from the current reported owner, Jackson Wijaya, or if some or all of it came from Sinar Mas and/or his close family members who control the corporate group. It is significant to note

that Jackson was reportedly 27 years old in 2007 when Paper Excellence was started<sup>120</sup>, and that no information could be found in the public domain to indicate any additional source of wealth or income generation beyond his family connections and positions with APP China, where he reportedly started working when he was 22 years old.

More recently, Paper Excellence has acquired two large companies - Domtar and Resolute - for a combined value of US\$5.7 billion. Publicly available documents provide little clarity on the source of equity investment, or whether Jackson Wijaya was representing just himself or his family as the named shareholder. As noted earlier in this complaint, SEC filings by both Domtar and Resolute report that "Jackson Wijaya" potentially includes "family members" of Jackson Wijaya. The SEC filings also report "co-investors" who are not identified by name. Given the financial connections between Paper Excellence and Sinar Mas identified above, legitimate questions arise about whether Paper Excellence's astronomical growth in the last five years has, at least in part, been underwritten by Sinar Mas, APP, and/or Widjaja family members who control the Sinar Mas Group.

#### Official government documents and proceedings

Along with the evidence presented above, government statements and other official documentation shed light on Paper Excellence's relationship with APP and Sinar Mas.

#### Inter-Corporate Ownership Database, Statistics Canada

The Government of Canada's national statistical agency maintains an annually updated database showing the ownership relationships of Canadian corporations. The Inter-corporate Ownership Database claims to be "the most authoritative and comprehensive source of

information available on corporate ownership; a unique directory of 'who owns what' in Canada." The 2021 edition of the database, published on June 17, 2022, identifies Sinar Mas Group as owning Paper Excellence and Asia Pulp & Paper. 123 According to emails made public in a Freedom of Information request, Statistics Canada affirmed this relationship to Paper Excellence when Paper Excellence's representatives challenged the finding. 124 The Statistics Canada director responsible for the Inter-corporate ownership database wrote to Paper Excellence's representative on October 13, 2022, "As of July 06th 2022, the information we have directs us to believe that Paper Excellence is ultimately owned by Sinar Mas."125 On October 30, 2023, Statistics Canada published the 2022 edition of the database in which the connection between Paper Excellence and Sinar Mas is severed. 126 Paper Excellence's parent company, according to the 2022 edition, is Elite Shine Investments Ltd in the British Virgin Islands, which the database indicates is controlled from Indonesia. 127 The Orbis database on private companies, one of the most comprehensive sources for data on corporate entities, identifies the Widjaja family as the owner of Elite Shine Investments Limited. 128 The 2021 edition of the Inter-corporate Ownership database indicates that the Sinar Mas Group owns Elite Shine Investments Ltd. 129

## Minister of International Trade, Export Promotion, Small Business and Economic Development, Global Affairs Canada

Minister of International Trade, Export Promotion, Small Business and Economic Development Mary Ng refers to Paper Excellence as "Sinar Mas" before the House of Commons Standing Committee on Natural Resources in February 2021. Minister Ng in her testimony stated, "Since 2015, the trade commissioner service has facilitated numerous forest-related investment projects to Canada, including into Quebec, Ontario, Alberta, New Brunswick and British Columbia. [...] Take for example, Sinar Mas from Indonesia. It has invested hundreds of millions of dollars to modernize paper mills in British Columbia, Saskatchewan and Nova Scotia..." \*\*Indonesia\*\* Glacier Media\*\* reported on Minister Ng's remarks in an October 2023 article, noting that

"Officially, the Sinar Mas Group has no paper mills in Canada. The only company that fits the company profile described by Minister Ng is Paper Excellence." Glacier Media sought clarification on Minister Ng's testimony: "When asked to explain why Minister Ng told the Standing Committee on Natural Resources the Sinar Mas Group had invested hundreds of millions of dollars in Canadian mills seemingly owned by Paper Excellence, a spokesperson with Global Affairs Canada refused to directly answer the question."

#### Competition Bureau Canada

Competition Bureau Canada, "an independent law enforcement agency that protects and promotes competition for the benefit of Canadian consumers and businesses", published a statement in December 2021 about its review of Paper Excellence's acquisition of Domtar. The Competition Bureau states, "Throughout the review of the Proposed Transaction, the Bureau learned that many industry participants view Paper Excellence and APP [Asia Pulp & Paper] as sharing a significant relationship." The Competition Bureau went on to note that there is a "widespread belief in the industry of a significant link between the two companies…"

#### Department of Finance and Treasury Board, Province of Nova Scotia

A briefing note sent to the Premier of Nova Scotia on January 29, 2019 by Nova Scotia's Department of Finance and Treasury Board stated of Paper Excellence's ownership that "PEC [Paper Excellence Canada] is ultimately controlled by Asia Pulp and Paper (APP), an integrated pulp and paper company (division of conglomerate Sinar Mas) based out of Indonesia. [...] APP's annual pulp and paper production volume exceeds 20,000,000 tons; therefore, NP [Northern Pulp] is likely a relatively small player within APP family of companies."<sup>134</sup>

#### Ministry of Energy and Resources, Province of Saskatchewan

In its 2011-2012 Annual Report, the Province of Saskatchewan's Ministry of Energy and Resources reported, "In April 2011 Paper Excellence, a subsidiary of the Indonesian company Sinar Mas, finalized the purchase of the Prince Albert pulp mill from Domtar." In 2009, then

Minister of Energy and Resources Bill Boyd stated in Saskatchewan's Legislative Assembly about a forest management area associated with the Meadow Lake Mechanical Pulp Mill: "The FMA [forest management area] is held by Mistik Management Ltd. The shareholders in Mistik Management Ltd. are NorSask Forest Products Inc. (50%) and Sinar Mas Group (50%)....Sinar Mas Group purchased its 50% share effective January 23, 2008."<sup>136</sup>

### United States District Court Southern District of New York, Petition by the United States Attorney for the Southern District of New York

U.S. Federal prosecutors from the Southern District of New York indicated the Widjaja family ultimately controlled Paper Excellence's parent company in the proceedings for a debt collection case against APP: A motion filed by Federal Prosecutor Preet Bharara in U.S. District Court in 2010 acknowledged that Jackson Wijaya owned 100% of the voting securities for Marque Technologies, which owned Paper Excellence's parent company Elite Shine Investments. The motion alleges that these companies were ultimately controlled by the Widjaja family and under common control with Sinar Mas.<sup>137</sup>

The *CBC* explains the situation that led to the motion by a Federal prosecutor in the U.S. District Court:

Sinar Mas's APP unit was looking to expand in North America. A subsidiary tried to purchase three bankrupt pulp mills in 2008. It hit a snag because various APP companies still owed a U.S. government agency \$144 million US following a huge default in 2001 and the U.S. government was trying to seize some of the funds for the mills purchase, court records show.

So APP tried another approach, according to the court filings. It transferred its right to buy the pulp mills into two newly incorporated companies that it didn't directly own, for no money. Both were then folded into yet another new, Dutch company: Paper Excellence BV, the first entity to bear that name.

The U.S. government moved to block the transfers, alleging they were implemented as "a shield for fraudulent or improper conduct" and that the Wijaya family had "hindered and delayed" debt collection efforts. The mill deal fell through.

#### British Columbia Legislative Assembly, Special Committee

In 2012, Mac Anderson, head of Mackenzie Fiber Management Corporation, a wood supply company owned by Paper Excellence, testified to a special committee on timber supply in British Columbia's Legislative Assembly: "Paper Excellence is owned by a company called Sinar Mas. Sinar Mas has over 32 pulp mills worldwide. They have some of the largest pulp mills in

the world. They have a number of other companies – Asia Pulp & Paper, etc. They're the largest manufacturer of tissue paper products, cardboard products in Asia."<sup>138</sup>

#### Office of the Commissioner of Lobbying of Canada, Lobbyist Registration

Moe Sihota, a prominent former politician, indicated Paper Excellence's affiliation with Sinar Mas on lobbyist registration forms over a period of almost two and a half years (see Appendix F for Moe Sihota's lobbyist registration). After the NGO report on Paper Excellence was published in October 2022, Moe Sihota removed his declaration of Paper Excellence's affiliation with Sinar Mas. When asked by Glacier Media why he started omitting Sinar Mas from his lobbyist registration, Sihota said that "he removed the link after he 'was approached.' I didn't understand the corporate structure at the time that I took on the file,' Sihota said. 'It was an error. I corrected it. OK?'" 140

#### Scope of "indirect involvement" (PfA v2) and "corporate group" (PfA v3)

Does Paper Excellence's relationship with APP meet the FSC's criteria for "indirect involvement" with APP? The FSC's Policy for Association is a "tool that allows" the FSC to "clearly define FSC's ability to take such action against companies that engage in any one of the activities listed as unacceptable." The "unacceptable activities" are "deforestation, destruction of High Conservation Values, illegal logging and illegal trade of timber, human and traditional rights violations, workers' rights violations, and use of genetically modified organisms." The FSC claims to be the "only" forestry certification scheme that "expects commitment to its core values by not only certified companies, but also other companies who belong to the corporate group of a certified company." The FSC warns that "organizations found responsible for these activities face exclusion from the FSC scheme."

On January 1, 2023, a new version (Version 3) of the Policy for Association came into force that recognizes a broader understanding of "corporate group". Unacceptable activities" that occurred prior to 2023 remain covered by the previous Policy for Association (Version 2). Under this previous version (Version 2), the scope of disassociation, i.e. "exclusion from the scheme", is defined by "indirect involvement."

#### Indirect involvement (PfA v2)

The "indirect involvement" paragraph of the FSC's Policy for Association version 2 (PfA v2) states:

Indirect involvement: Situations in which the associated organization or individual, with a minimum ownership or voting power of 51%, is involved as a parent or sister company, subsidiary, shareholder or Board of Directors to an organization directly involved in unacceptable activities. Indirect involvement also includes activities performed by subcontractors when acting on behalf of the associated organization or individual.<sup>146</sup>

APP is an organization that has been found by the FSC to be involved in "unacceptable activities" and for which the disassociation, first instituted in 2007, remains in force. This complaint provides evidence indicating that Paper Excellence, like APP, is controlled by Sinar Mas. We believe that FSC staff already know this given the abundance of evidence. It appears the FSC has not taken action against Paper Excellence because it considers that Paper Excellence and APP must have the same majority shareholder to meet the criteria for "indirect involvement". This position is evident both in the FSC's public statements about the Paper Excellence case and in recent comments made more generally describing the "indirect involvement" criteria as taking an ownership-based approach to corporate responsibility.

The FSC's use of ownership as the sole criteria for determining "indirect involvement" is at odds with FSC's own policy and international accounting standards that say control – with or without formal ownership of a majority of the equity shares – is the basis for determining parent/subsidiary corporate relationships. The control-based standard is well-established, and it undermines the FSC's interpretation of "indirect involvement" as only based on formal equity ownership and voting rights.

Updated in 2021, the FSC policy document that defines the process for its handling of Policy for Association complaints defines "affiliated group" as: "The totality of legal entities to which an associated organization is affiliated in a corporate relationship in which either party controls the performance of the other (e.g. parent or sister company, subsidiary, holding company, joint venture) as described in Policy for Association FSC-POL-01-004." The determination of corporate relationship and affiliation is "control", not "ownership", according to this FSC policy.

A control-based approach is also prescribed in the international accounting standard used by the FSC to prepare its own financial statements, IFRS, states that the determining factor for parent/subsidiary relationships<sup>151</sup> is control, not ownership: "An investor, regardless of the nature of its involvement with an entity (the investee), shall determine whether it is a parent by assessing whether it controls the investee." This definition is from IFRS 10 on *Consolidated Financial Statements*, which addresses the determination of "parent" and "subsidiary" relationships for the purposes of financial reporting and corporate consolidation.

IFRS 10 clearly states that "control", not "ownership", is the basis for determining "parent" relationships. The accounting standard's criteria for determining control: "An investor controls an investee when it is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee." The accounting standard cautions against relying solely on ownership to determine parent/subsidiary (and, by extension, sister company) relationships:

Power arises from rights. Sometimes assessing power is straightforward, such as when power over an investee is obtained directly and solely from the voting rights granted by equity instruments such as shares, and can be assessed by considering the voting rights from those shareholdings. In other cases, the assessment will be more complex and require more than one factor to be considered, for example when power results from one or more contractual arrangements.

In regards to Paper Excellence, have Sinar Mas and APP ever met the criteria for control per IFRS 10? The evidence documented above shows: a first-degree family relationship (parent/child) between APP's Chairman and Paper Excellence's reported owner; Paper Excellence's reported owner held key management positions in APP China; and statements by former APP and Paper Excellence staff demonstrating that APP's Chairman was a key decision-maker for Paper Excellence. The evidence further shows that APP senior management

personnel held key management positions in Paper Excellence. Leaked emails, as reported on by multiple media outlets in March 2023, show that APP staff were directing Paper Excellence's behavior in significant ways that could affect Paper Excellence's returns, such as deciding when and to whom to sell its products, collaborating on representations made to a national regulator, and providing market forecasts.

Finally, official government documents and proceedings recognize that the Sinar Mas Group, owner of APP, controls Paper Excellence as well. This official record includes: testimony in 2021 by a senior Federal official to a Standing Committee of the House of Commons; a determination of ownership in 2021 by an "authoritative" database from Statistics Canada on corporate ownership; a briefing note in 2019 from the Nova Scotia Treasury Department to the Premier of Nova Scotia; a position statement in 2021 from the Competition Bureau Canada; and a motion by a Federal Prosecutor in U.S. District Court in 2010 alleging fraud.

The set of documented facts and the official record strongly indicate that Sinar Mas has had "power" over Paper Excellence "to direct activities that most significantly affect the returns of the investee" per IFRS 10's definition of control. <sup>154</sup> (A similar analysis applies to the criteria for variable interest entities in Generally Accepted Accounting Principles (GAAP). <sup>155</sup>) Furthermore, legitimate questions about whether the source of Paper Excellence's equity investment and financing is Sinar Mas and/or members of the Widjaja family indicates the strong possibility that Sinar Mas' beneficial owners are exposed to and have rights to the variable returns of Paper Excellence. Based on the "preponderance of evidence" standard applied to PfA cases <sup>156</sup>, we are confident that the FSC will determine that it is more likely than not that Sinar Mas controls Paper Excellence.

#### Corporate group - PfA v3

Does Paper Excellence's relationship with APP meet the criteria for "corporate group" in accordance with PfA v3? Applying to violations that occur from January 1, 2023 onwards, the determination that Paper Excellence and APP are in the same corporate group would mean that, going forward, violations by APP could impact Paper Excellence's membership status in the FSC and vice versa.

To define a corporate group, the PfA v3 identifies factors of control aligned with the Accountability Framework Initiative's definition of corporate control. The AFI definition

recognizes ways that parent entities can control subsidiaries through non-formal arrangements, which can include management control, shared resources, and hidden beneficial ownership.<sup>157</sup>

Based on the AFI's factors of control, the facts established above offer compelling evidence that Paper Excellence is part of the Sinar Mas Group.

Beneficial ownership: Is ultimate ownership hidden in offshore companies or by the use of nominees?

Paper Excellence's shareholder companies span multiple offshore jurisdictions, which has the effect of concealing the ultimate beneficial owners. SEC filings for Domtar and Resolute Forest Products state that "Jackson Wijaya" could mean any of his family members, <sup>158</sup> raising the possibility that Jackson Wijaya is a nominee for the ultimate controlling shareholders of Sinar Mas and APP. Accounts by former Paper Excellence staff that Teguh Ganda Widjaja, APP's Chairman, was making key decisions for Paper Excellence from his office in Shanghai<sup>159</sup> underscore the possibility that Jackson Wijaya is a nominee.

Formality of relationship: Is there formal ownership, such as through an investment holding structure?

Due to Paper Excellence's opaque ownership structure, we can neither conclude nor rule out that Paper Excellence's ultimate beneficial owner(s) overlap with APP's shareholders or shareholders of other Sinar Mas companies. It is significant that in 2021 Canada's authoritative database on corporate ownership recognized Sinar Mas' ownership of Paper Excellence and

APP<sup>160</sup>, and that Canada's Minister of International Trade apparently understands Paper Excellence to be Sinar Mas.<sup>161</sup>

Declared as a group: Has the group publicly declared the companies are linked? Initially Sinar Mas acknowledged its connection to Paper Excellence's first mill acquisition through issuing a press release to announce the acquisition in 2007<sup>162</sup> and including its name on the mill's letterhead for the next three years until 2010.<sup>163</sup> More recently, Paper Excellence has made public statements that it is independent of APP and Sinar Mas, including after multiple media investigations were published in March 2023.<sup>164</sup> In May 2023, a Paper Excellence executive testified at a committee hearing in Canada's House of Commons that Paper Excellence received help from Sinar Mas until 2015.<sup>165</sup>

Family control: Are the companies owned or run by members of the same family?

Paper Excellence and APP are owned and run by members of the same family. Paper Excellence's apparent owner, Jackson Wijaya, is the son of APP's Chairman and shareholder, Teguh Ganda Widjaja. 166 Jackson Wijaya's sister, Linda Wijaya Limantara, has been a managing director and shareholder of APP. 167 Jackson Wijaya's uncles – Muktar Widjaja, Franky Widjaja, and Indra Widjaja – have been shareholders of APP. 168

Financial control: Are there contractual or other financial arrangements that indicate one party controls the performance of another?

In 2010, a bank in China owned by Sinar Mas<sup>169</sup> made a US\$17.5 million loan to Paper Excellence at a near-zero percent interest rate.<sup>170</sup> In 2011, Paper Excellence B.V. reported in its Annual Report that the "shareholder loan" of US\$17 million in 2010 increased to US\$70 million as of December 31, 2011.<sup>171</sup> Through 2014, Paper Excellence B.V.'s reported shareholder investment in the form of share premium totaled close to US\$800 million<sup>172</sup> – a period in which "help from APP Sinar Mas" was provided to Paper Excellence, according to the recent testimony of a Paper Excellence executive at a committee hearing in Canada's House of Commons.<sup>173</sup> Similarly, Paper Excellence issued a press release in March 2023 that stated: "It is well known that Jackson Wijaya, the ultimate and sole owner of Paper Excellence, is the son of the current head of APP. In the early days, Jackson benefited from some experience gained from the family business early in his life, as well as support getting his company started."<sup>174</sup>

Paper Excellence has recently acquired two large companies - Domtar in 2021<sup>175</sup> and Resolute Forest Products in 2023<sup>176</sup> - for a total investment of US\$5.7 billion. Publicly available documents provide little clarity on the source of equity investment for the acquisitions of Domtar and Resolute. SEC filings by both Domtar and Resolute state that "Jackson Wijaya", the

reported investor making these acquisitions, potentially includes "family members" of Jackson Wijaya. The SEC filings also report "co-investors" who are not identified by name. The second sec

Management control: Is there extensive overlap in officials between companies? Three directors (Suresh Kilam, Tei Ah Lek, and Danilo Benvenuti) of APP companies served at the same time as directors for Paper Excellence companies. And a longtime and current director of Paper Excellence companies (Hardi Wardhana, aka Peter Wardhana), listed his address at Sinar Mas headquarters in Jakarta on official documents as late as 2018. Jackson Wijaya also held key management roles in APP China at the same time as he was reportedly the owner of Paper Excellence.

Shared resources: Do companies share a registered address, land or other physical assets, or provision of company functions or services?

A collaborative media investigation published in March 2023 that included the *CBC* "found leaked records and insider accounts that show that Paper Excellence, at least until a few years ago, appears to have been closely – and secretly – coordinating business and strategy decisions with Asia Pulp & Paper, one of the world's biggest pulp-and-paper players, which has a track record of environmental destruction."<sup>179</sup> The leaked emails, according to multiple media reports, show APP staff: directing Paper Excellence on when and to whom to sell its products, collaborating on representations made to a national regulator on behalf of Paper Excellence, and providing market forecasts. According to the whistleblower that provided the emails, "APP staff *is* PE staff. There is no difference there."<sup>180</sup>

## Overview of the steps that have been taken to resolve the issues prior to lodging this complaint and the response that was provided

Auriga Nusantara, an NGO based in Indonesia, sent a letter in October 2019 to the FSC's Director General and Chair of the International Board of Directors about Jackson Wijaya's involvement in APP. Nine months later, in a letter dated July 15, 2020, FSC Director General Kim Carstensen stated: "Our analysis confirms that Jackson Widjaya [sic] controls over 51% of Paper Excellence and shows that he is involved with APP China through Ever Dragon Investments, which would qualify Paper Excellence as being indirectly involved with an indirectly involved organization. With this, we have found Jackson Widjaya [sic] positioned one degree removed from the disassociated group." 181

In October 2022, Greenpeace Canada with other organizations published a report, *Papering over corporate control*, which details Paper Excellence's extensive links with APP and Sinar Mas beyond Jackson Wijaya's management positions with APP China. The report stated, "The substantial evidence compiled in this report requires a response from FSC that includes initiating its own Policy for Association (PfA) investigation of the links between Paper Excellence and APP." To the best of our knowledge, the FSC has not initiated such an investigation at the time of this complaint's submission, nor did it issue any public comments addressing the findings of the report.

In March 2023, several media organizations published stories about Paper Excellence's relationship with APP and Sinar Mas as part of the Deforestation Inc investigation led by ICIJ. In response to those stories, the FSC issued a press release, which stated: "FSC has evaluated the shareholder interests between Paper Excellence and the APP Group multiple times and has concluded each time that there is no majority ownership relationship between APP and Paper Excellence." The FSC Director General was quoted by *Radio France* on March 1, 2023 as stating in response to the publication's reporting on Paper Excellence, "There is no relationship between APP on the one hand and Paper Excellence, Fibre Excellence on the other."

Since the FSC conducted its most recent assessment in 2021 of Paper Excellence's relationship with APP and Sinar Mas,<sup>185</sup> new and compelling evidence from NGO, media, and government investigations about the relationship has entered the public domain. In this time, the FSC has also updated its corporate responsibility policy, though the old policy continues to apply to infractions prior to 2023. This complaint presents evidence showing that Paper Excellence's ongoing membership contravenes both FSC's old and new policies.

Dear Timer Manurung,

Thank you for your letter dated October 24, 2019 regarding Paper Excellence and its corporate connection with the APP Group. We greatly appreciate Auriga's work in documenting and researching the complex corporate structures and relationships involving the Widjaya family and the Asia Pulp and Paper Group. We have studied the documents and the Notice of Listing by Green Fortune Capital Limited. According to our review and analysis of the documentation, there remains intact a corporate ownership division between the shareholdings of Paper Excellence and Asia Pulp and Paper, and thus we do not find the requisite 51% ownership under the Policy for Association.

Our analysis confirms that Jackson Widjaya controls over 51% of Paper Excellence and shows that he is involved with APP China through Ever Dragon Investments, which would qualify Paper Excellence as being indirectly involved with an indirectly involved organization. With this, we have found Jackson Widjaya positioned one degree removed from the disassociated group.

At this time FSC will not rescind certification of the listed Paper Excellence companies as we cannot show indirect involvement as per the FSC Policy for Association. The submitted information is nonetheless helpful and serves as a reminder of the complexity of corporate structures.

As you are aware, we have suspended discussions with APP for among other issues a lack of transparency in corporate structures. We encourage our stakeholders to continue submitting any relevant information on APP Group and any allegations of violations of the Policy for Association. FSC values the work of Auriga and partner organizations and looks forward to working together in the future for responsible forest management. Thank you again for your letter,

In addition, APP has a formal policy that states it will respect the rights of indigenous communities. To date, APP and Sinar Mas operations directly and indirectly support millions of families; most of whom live in remote villages and rural communities.




