Established in 1971, Greenpeace Canada is part of a global campaigning network maintaining general consultative status with the United Nations Economic and Social Council. To advocate and mobilize effectively, including in ways that charities can't, Greenpeace Canada is a non-profit rather than a charity.

Established in 2020, the Greenpeace Canada Education Fund is a registered charity focused on research, investigations and education. Our work complements and supports that of Greenpeace Canada and environmental partners by creating persuasive, credible and effective actions that meaningfully engage the public, politicians, and the media on the march toward climate justice.

With active projects investigating the role of fossil fuel companies in stymying climate action, we will establish ourselves as a source of compelling climate research and share these findings with the public.

## 2022 ACCOMPLISHMENTS

In 2022, we made a series of strides as a maturing organization. Having developed working systems and charitable activities in 2021, we made progress by launching our first research project, connected to foundations and educational partners in Canada as we developed our Greenspeakers environmental education program for youth, and started regular supporter communications.

#### Increasing our Public Profile and Supporter Communications

We developed our website, started sharing updates on Facebook and LinkedIn, and began producing newsletters for our supporters with the aim of being transparent and sharing valuable information about our nascent programming initiatives.

#### Understanding the Environmental & Youth Education Landscape in Canada

With the goal of supporting the current GPC Greenspeakers environmental education program for youth, we prioritized foundation engagement, holding discovery meetings with prospective foundations and educational partners. We learned a lot about what is already happening in this critical field and how we can optimize the current program for the greatest benefit.



## 2022 ACCOMPLISHMENTS (CONTINUED)

### Initiating the Greenspeakers Audit

After a process of analyzing stakeholder engagement for Greenspeakers, including learnings from other Greenpeace offices and meeting with volunteers and coordinators across the country, we commissioned an education expert to conduct a rigorous audit of the program. This assessment will inform the shape the program could take, on the basis of needs and impact.

#### Launching our first research project

We received a grant to fund a new research position, based at Greenpeace Canada, to analyse the influence of fossil fuel companies in stymying environmental regulation in Canada and to share the results of this work through ongoing engagement with the public. We received funding beginning in April and kickstarted our research activities.

## **KEY PROGRAMS: GREENSPEAKERS**

Greenpeace Canada's Greenspeakers program empowers Canadian youth to find creative solutions to local and global environmental challenges through educational resources, thought-provoking speakers, and interactive learning sessions. It has engaged more than 17,000 students from K-12 and 328 schools across Canada since 2015.

GCEF is now seeking to support the development, standardization, and scaling of the program across the country.

In 2023, we hope to help define an upgraded program that closely aligns with educator and student needs and works in partnership with provincial curricula and existing educational partners.

### KEY PROGRAMS: NEUTRALIZING OIL & GAS INDUSTRY INFLUENCE ON CANADIAN CLIMATE DISCOURSE

In 2022 we began our first research project. Work began in the second half of the year in earnest with a significant amount of focus on initial research. Major deliverables from this research became public in early 2023. These include:

- <u>So Sue Me</u>, a research report on the use of greenwashing by Canadian banks.
- Responsive and proactive research outputs related to the fossil fuel industry. Ongoing outputs include a blog series on its activities and providing tools for Greenpeace supporters to call for a windfall tax.
- The senior Researcher & Writer at GPC has also seized responsive opportunities to highlight the bad behaviour of fossil fuel companies, including spearheading a complaint to Canada's competition bureau against the recent "Let's Clear the Air" Pathways Alliance advertising campaign.
- Ongoing collaboration with journalists and publications to create content that informs the public.

The research work we are supporting underpins the broader objective of helping to shift the public narrative on fossil fuel companies in Canada by meaningfully informing the Canadian public. We hope to share these results with you in the near future.

## **2023 OBJECTIVES**

In 2023, we will continue to develop our programming portfolio to identify and support new research and education projects.

Our objectives this year include:

### 1. Developing our education and research initiatives

This year, we will strengthen our education offerings by contributing to a new design for the Greenspeakers environmental education program and building on the success of our first research project by developing a vision for sustainability, identifying new areas of inquiry, and engaging foundations and supporters to support it.

## 2. Expanding strategic communications while maintaining our commitment to transparency

In 2023, we will deepen our communications with our existing base of supporters, showcasing progress with our existing programs and providing a lens into the charity as we grow and develop.

### 3. Nurturing relationships with foundations, partners, and supporters

Informed by our learnings from last year, we will expand engagement activities with our key stakeholders, pursuing collaborations on new programs with key foundations and educational partners, and engaging our supporters for support and feedback as we develop our programming portfolio.


### 4. Strengthening governance processes

### MESSAGE FROM THE EXECUTIVE TEAM

It was an honour for both of us to be involved in the growth of the Greenpeace Canada Education Fund in 2022. The charity achieved some big first milestones, including securing a significant grant to conduct investigative research over two years on the influence of fossil fuel companies in Canada and launched an assessment of our existing environmental educational offerings. Both initiatives have unlocked so much potential for our future work.

Already in 2023, the investigative researcher hired by GPC last year, through our funding, has produced a report called <u>So Sue Me</u>. This report outlines how the failures of banks globally to meet their climate mitigation promises are spurring legal actions from governments and civil society. This research also found that Canadian banks are likely to encounter the same repercussions as they continue lauding their climate goals while financing the fossil fuel industry. Sharing research findings like this with the public is part of the reason that GCEF exists.

In addition, the environmental education assessment we began in 2022 is now complete. This report will help GCEF interpret what's already happening in the field and determine how best we might grow the existing program to meet the significant environmental education needs in our schools. Having school-aged children of our own, this project's success is particularly close to our hearts.

We enjoyed sharing updates with our supporters last year and truly appreciated the opportunities we had to connect with some of you personally over the phone or by email. Thank you so much for your support of GCEF in 2022. Your feedback and commitment really helped us move the dial last year.

Thanks for being here with us as we work to close the knowledge gap by conducting research and raising awareness about the environmental issues and solutions we face. We strive to advance our mission while applying an intersectional equity lens in all that we do, from program design to outreach activities. We are looking forward to what we will accomplish together this year for a more just and sustainable planet.


