Dear Commissioner Cadiz:

We write on behalf of our clients, Chevron Philippines, Inc. ("Chevron Philippines") and Chevron Holdings, Inc. ("Chevron Holdings"), regarding (i) the Consolidated Reply dated 10 February 2017 ("Consolidated Reply"), which was filed in the aforesaid case, and (ii) the Order dated 16 March 2017 with attached Notice of the same date ("Order"), which was issued by this Honorable Commission. Copies of the Consolidated Reply and Order were received by Chevron Philippines, by registered mail, on 22 February 2017 and 27 March 2017, respectively, while a copy of the Consolidated Reply was received by Chevron Holdings on 22 February 2017.

proper disposition. For the same reasons stated above, we are likewise returning this Honorable Commission's Order.


