## **Dan Hindsgaul, Board Chair (2016-2025)**

Dan Hindsgaul was elected as a member of the Greenpeace Nordic Board of Directors in 2016. Dan is an experienced international campaigner and communicator in the fields of human rights, democratization, environmental protection and WMD disarmament. In 2022, Dan was elected as the Board Chair for Greenpeace Nordic. He currently works as the Head of Policy at Save the Children Denmark. Dan lives in Denmark.



## **Andrea Cederquist, Board member (2019-2025)**

Andrea Cederquist was elected to the Greenpeace Nordic Board in May 2019. She has years of experience in social change management and strategy, working for mainly for NGOs and in Academia. She is a trained biologist and holds a M.Sc. in Environmental Management and Policy. She has previously worked as biodiversity campaigner both for oceans and forests in international Greenpeace campaigns. Her academic engagement has been relating to transformational learning processes. ## **Per Rosander, Board member (2019-2025)**

In 2003 Per started the International Chemical Secretariat (ChemSec), an NGO acting to promote stronger chemical legislation in particular on EU and global level, and was the ED of the organisation for number of years. ### **Ingrid Skjoldvær, Board member (2023-2026)**

Ingrid Skjoldvær was elected to the Greenpeace Nordic Board of Directors in May 2020, and re-elected in 2023. Ingrid is an environmental activist and campaigner with experience from several NGOs, including chairing Nature and Youth, Norway's largest youth environmental organisation.
